



**IN-POOL THERMOPLASTIC STEP  
LIMITED WARRANTY**

Quaker Plastics, a division of Cardinal Systems, Inc., hereafter referred to as "Quaker Plastics", warrants to the original retail consumer purchaser that if a Quaker Plastics Step should fail structurally due to a manufacturing defect within twenty-five (25) years from the date of original installation, and that the warranty form has been properly registered online at [cardinalsystemsinc.com](http://cardinalsystemsinc.com) or that the attached warranty card has been completed, signed, and returned to Quaker Plastics within thirty (30) days of original installation, Quaker Plastics will, at its sole option, repair any such defect or, in the alternative, supply a new step, F.O.B. Schuylkill Haven, Pennsylvania, on a no-charge basis.

This warranty is subject to the following terms and conditions:

Quaker Plastics shall not be responsible for the cost of the removal or replacement of any defective step, nor for any other expenses or damages that might be incurred in such removal and/or replacement, including but not limited to costs of transporting the defective step to Quaker Plastics or other designated location.

This warranty relates only to manufacturing defects and does not include staining, fading, discoloration, or damage or failure resulting from other causes, including, but not limited, to acts of God, misuse or abuse, accident, negligence, fire, improper installation, including failure to properly affix supplied brace support system as described in instructions, and/or maintenance, or defects in the raw material.

This warranty is enforceable only on the original retail consumer purchaser within the term of this warranty and this warranty applies only to Quaker Plastics in-pool thermoplastic pool steps purchased for private residential use.

This warranty shall be void unless the attached warranty registration card is completed and submitted online at [www.cardinalsystemsinc.com](http://www.cardinalsystemsinc.com) or signed and returned to Quaker Plastics at the address below within thirty (30) days of installation by the original retail consumer purchaser.

QUAKER PLASTICS SHALL NOT BE LIABLE FOR ANY CONSEQUENTIAL OR INCIDENTAL DAMAGES, INCLUDING BUT NOT LIMITED TO ANY DAMAGES FOR LOSS OF USE OF POOL OR INJURY TO PERSON OR PROPERTY, AND ANY CLAIMS THEREFORE ARE HEREBY SPECIFICALLY DISCLAIMED AND EXCLUDED. SOME STATES DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATION OR EXCLUSION MAY NOT APPLY TO YOU. THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS AND YOU MAY ALSO HAVE OTHER RIGHTS, WHICH MAY VARY FROM STATE TO STATE.

Quaker Plastics makes no other warranty, express or implied, and any statutory warranties, including implied warranties of MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, are hereby specifically disclaimed and excluded.

No representative of Quaker Plastics or any of its agents, distributors, or dealers has any authority to alter in any manner the terms of this warranty and Quaker Plastics is not responsible for any undertaking, representation or warranty made by any other person beyond those set forth in this warranty certificate.
